

## What You Need to Know about Overdrafts and Overdraft Fees

An <u>overdraft</u> occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. PrimeTrust Financial can cover your overdrafts in two different ways:

- 1. PrimeTrust Financial offers standard overdraft practices that come with your account
- 2. PrimeTrust Financial offers an <u>overdraft protection plan</u> that links your savings and checking accounts. To learn more, ask us about this plan.

For Members who qualify, this notice explains our standard overdraft practices.

## > What are the standard overdraft practices that come with my account?

PrimeTrust Financial DOES authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

PrimeTrust Financial DOES NOT authorize and pay overdrafts for the following types of transactions unless you ask us to by signing the one-time consent form attached to the bottom of this form.

- ATM transactions
- Everyday Debit Card transactions

We pay overdrafts at our discretion, which means we <u>do not guarantee</u> that we will always authorize and pay any type of transactions.

If we <u>DO NOT</u> authorize and pay an overdraft, your transaction will be declined.

- What fees will I be charged if PrimeTrust Financial pays my overdraft? Under our standard overdraft practices:
  - We will charge you a fee of \$28.00 each time we pay an overdraft
  - There is <u>no limit</u> on the total fees we can charge you for overdrawing your account.

## What if I want PrimeTrust Financial to authorize and pay overdrafts on my ATM and everyday Debit Card transactions?

If you want PrimeTrust Financial to authorize and pay overdrafts on ATM and everyday Debit Card transactions, you will need to complete this form and return it to us at any branch or by mailing it to Attn: Electronic Services, PrimeTrust Financial Federal Credit Union, 3700 West Bethel Avenue, Muncie, IN 47304.
